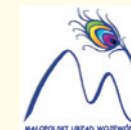

## Events within the Conference:

### 1. Polish-Italian-Ukrainian-Serbian Scientific Seminar

This year's conference will be linked to the session of the 13th Polish-Italian-Ukrainian-Serbian Scientific Seminar entitled *Challenges of contemporary economies in the face of global market conditions. Economic, Social and Legal Aspects* held within the cooperation of the Cracow University of Economics in Cracow with the University of Messina, Kyiv National University of Trade and Economics and the University of Kragujevac.

### 2. The first Cracow scientific seminar on the applications of nonparametric statistics and robust statistics in economics

On the first day of the conference (25th May 2015), a scientific seminar on the applications of nonparametric and robust statistics in economics will be held, the aim of which is to create a platform for the exchange of thoughts, present the participants' own ideas, establish contacts and cooperation among the scientists from various scientific centres, research institutions and enterprises interested in the applications of nonparametric and robust methods in broadly understood economics and empirical finance. A one-day seminar will consist of three parts: a plenary lecture, a discussion session and a poster session on the applications of R-environment in economics.

### 3. Student and doctoral session

Within the framework of the conference sessions, traditional panel sessions intended for students and doctoral students of Polish and foreign universities will take place. It is an annual forum of the exchange of knowledge, thoughts and views of the community of students and doctoral students from all over the world. The fruit of these sessions is also a separate publication, collecting the output of the student session participants in the form of a monograph, whereas doctoral students' papers are published in the main, reviewed conference monograph.
